#### **NEW BUSINESS**

Ambulance rate adjustment - Chief

The fire chief recommended raising our ambulance transport rate to \$1,200 and \$26.00/a mile effective January 1, 2025. A motion by Commissioner McMaster and seconded to approve the rate adjustment was carried.

# DISTRICT SECRETARY'S REPORT - Retirement/Replacement

The draft district secretary job description and recruitment announcement were reviewed, and the fire chief will update the drafts and publish the announcement.

There are administration processes that do not occur monthly or quarterly for which training will be needed. The current district secretary has agreed to return as needed when available as an independent contractor to provide additional training to the new district secretary.

A motion by Commissioner McMaster and seconded to approve the district secretary job description and the recruitment announcement was carried.

FINANCIAL REPORT – The Thurston County Treasurer's report with account balances as of September 30, 2024, is not available yet from the county.

This form is due 48 hours before the release of funds. The district secretary is an authorized signer. To meet the two time requirements the district secretary may sign and submit the form to the County Treasurer's office before the monthly fire commissioner's meeting. The amounts due will be formally approved at the monthly meeting.
