At 1800 hours Commissioner Harry Miller called the meeting to order. Present at Station 17-1 were Commissioners Harry Miller, Gerald Bickett and Diana McMaster, Fire Chief Mark Gregory, Captain Mark Edwards, and District Secretary Amanda Stygar. AGENDA: The motion by Commissioner Miller and seconded to approve the agenda was carried.

MINUTES: The motion by Commissioner Miller and seconded to approve the minutes of April 10, 2025, was carried, and the minutes were signed.

PUBLIC COMMENT: The board received public comments from three members of our community regarding concerns about roadway access to a certain residential area within the district. These individuals reported that a landowner had extended a fence line, which the landowner believes aligns with their property boundary lines. The change in fence line does reduce the width of a shared roadway that is vital for access to several homes in this neighborhood. This modification raised concerns about the ability of emergency vehicle access to the area if needed. The board and Chief acknowledged the potential issues and committed to further investigating the matter. A formal response will be provided to the residences of this area including the landowner upon completion of the review.

Monthly meeting - A general discussion was held.
